It should be noted, however, that since both types of society enjoy authoritarian and dictatorial regimes, the possibility of social change from the people's perspective seems very difficult, and people have not the ability to change and create a safe and secure environment for themselves. A war-torn society and a tyrannical society are precisely an area devoid of security and denied the right to a decent standard of living. So we see that the "great or mass emigration of its present type" comes from these kinds of societies only. In fact, many people in these societies, which are largely incapable of coping with the misery of their country, turn a blind eye to their homeland and challenge their true identity in the ancestral land, fleeing their homeland and migrating to the land of dreams in a modern and advanced world. Finally, a miserable society is in

the process of escaping from the backward lands (ancient society) and ending with the migration to progressive lands (modern society).

The pivotal point in mass immigration is that the target society in the minds of most immigrants is merely the Western bloc, and in the Western bloc some of the specific countries of America, England, France and Germany are still the target of immigration. This means that even the leading Eastern countries are not the target of widespread immigration and are less likely to go to Japan, South Korea and China. ### **Reasons for Social Differences**



In fact, these two components are the driving forces of every nation and society. These are the factors that signify the orientation of society and constitute the purpose of society. So the merit of every nation or society is in these two impulses. If cultural poverty in African and Asian societies results in an attitude of struggle for the people, and it will eventually lead society to war. South and Central American societies also tend to despotic government for cultural poverty. Although African and Asian societies are certainly moving toward authoritarian society. That is why it can be said with certainty that the most fundamental reason in today's world of large-scale migration (multiple migration events in the Third World) is based on the "social culture and attitude of nations and the manner and plan of governance in countries". Is. Factors that, if made in error, undoubtedly lead to deviation society. So in this case, society faces a multitude of different problems and public discontent is formed. And this is why the issue of escape country has evolved and a large number of unhappy people migrate to advanced countries.

But the interesting point is that these two factors affect each other and each affect the other. That is, it is necessary for the large human community, along with the backward societies (in an institution called the United Nations), to make significant and significant changes in the following areas:

- The foundation of community structure
- Functional culture of the community

That is, by rebuilding the way we look at life, we remove the superstition and malice from frozen and pointless life and move it to new, modern contexts.
